The Global Snakebite Initiative (GSI) is a registered non-profit organisation committed to improving the understanding, prevention and treatment of snakebite in the developing world. The Initiative was formed in an effort to improve recognition of the harm that snakebite inflicts on many of the world's most impoverished rural people, particularly in Africa, Asia, New Guinea and Latin America.

Full Ordinary Membership of the Global Snakebite Initiative is open to health professionals, scientists, policy makers, institutions and corporations with direct interest in relevant fields. These members have voting rights under the GSI Constitution, and are able to participate in the work of the organisation.

Members of the public, including individuals and corporations who wish to lend their support to the Initiative are eligible to apply for Associate Membership, and receive regular newsletters and updates.

Article 20.3 of the GSI Constitution provides for free membership of the Global Snakebite Initiative for applicants who are legal citizens of, or are organisations legally constituted in, Developing or Emerging Economies, as per United Nations classifications.
